The petition for Injunction for Protection Against Domestic Violence filed under section 741.30, Florida Statutes or Repeat Violence, Dating Violence, or Sexual Violence under section 784.046, Florida Statutes, has been reviewed. This Court has jurisdiction of the parties and subject matter.
